1. **SCOPE Of WORK :** Manufacturing and supply of the stores strictly as per requirement and specification/drawings stipulated in the tender form.
2. **SUBMISSION OF TENDER :** Offer addressed to **JUNIOR MANAGER (PURCHASE)** should be submitted within the due date and time as stipulated in the tender, superscribing the name of the tender. Tender reference no. due date & time on the top of the envelope.
3. **EARNEST MONEY DEPOSIT :** The tenderer are required to deposit Earnest Money as per table given below in the form of demand draft/pay order drawn in favour of Burn Standard Company Limited, Burnpur Works, Burnpur.

6. **INSPECTION :** The finished materials shall be inspected by BSCL/BW/RDSO or their authorised representative at your works/our works as the case may be. All testing and inspection facilities are to be extended by the tenderer free of cost. In case finished materials are inspected by RDSO. DM to be attached along with your supply. Material Test certificate both physical and chemical and guarantee certificate to be submitted during inspection/supply as the case may be.
7. **DELIVERY :** To be commenced within 15 days after receipt of formal order/LOI and thereafter supplied may be made as per requirement of Burn Standard Co. Ltd, Burnpur Works.

8. **TERMS OF PAYMENT :**
- a) Our payment terms is 30 (thirty) credit from the date of submission of bill against supply of stores. Any deviation against terms may not be acceptable during evaluation of offer.
 - b) Those who could not maintained the desired quality of this items and have been communicated by us on previous occasions must confirmed that their product has been modified /up graded to meet the quality requirement. For this specific vendors the proforma payment terms is not acceptable and will be summarily rejected with such payment terms.
9. **VALIDITY OF OFFER :** Tenderer should keep their offer valid for acceptance by the company for a minimum period of 90 (Ninety) days from the date of opening of the tender, within which period tender can't withdraw his offer.
10. **PRICE : Tenderer must confirm that their quoted rate is firm till execution of the contract and no escalation in the price will be considered during pendency of the contract price must be FOR Burn Standard Company Limited, Burnpur Works, Burnpur OR Howrah Works, Howrah.**
11. Rate should be quoted in the unit mentioned in the tender form indicating basic price with additional charges like Excise Duty, Sales Tax / VAT, Octrol etc. should be shown separately. Rates should be quoted in words and in figures neatly. Erased or over within rates will disqualify the tender. Rates once offered and accepted will hold good for the whole contract period.

19. **OPTIONAL CLAUSE :** The purchase reserves the right to increase/decrease up to 30% (thirty) percent of the ordered quantity during the currency of the contract at the same price and terms and condition with suitable extension of the delivery period, or short closing the order as the case may be.
